ECS is committed to educational and spiritual excellence. It takes a great deal of prayer, time, and resources to continue our tradition and reach students & families. First and foremost, we covet your prayers! Please make ECS a regular part of your prayer time. Second, there are many opportunities to volunteer and get involved through our Parent-Teacher Fellowship.



Contributions - Contributions may be made to ECS at any time and are tax deductible to the extent permitted by law. A donation may be made as part of your tuition payment plan or via automatic monthly bank transfer (ACH). We also have a special focus during our Annual Campaign for Excellence, including our **Worthy Servant's Fund** which provides a Christmas bonus to our teachers and staff. Gifts of stock and appreciated assets may offer you potential tax advantages. Some employers will match your donation – thereby doubling your support.

In addition, there are several opportunities to support our school, one which offers significant tax **CREDITS** and some which cost you nothing. Please consider supporting your school in the following ways:

SGO Contributions – You are able to make a donation to the Institute for Quality Education (I4QED; our partner SGO) which provides tuition assistance to help students attend ECS. Donations to I4QED are eligible for a 50% Indiana State Tax CREDIT and are deductible for federal income tax purposes. For example, a \$2,000 donation would typically cost the donor less than \$500 out-of-pocket. Gifts of stock are also accepted and offer additional tax advantages. Donations may be made on-line at www.I4QED.org and be sure to designate ECS as the school to receive your support. A brochure is available in the school offices.



SCRIP Cards – are easy to use, cost you nothing, and lower your tuition! You purchase gift cards that are used just like cash at full face value. Because the SCRIP are purchased with cash upfront, ECS is able to purchase the certificates at a discount which is divided equally between the school and ECS families in the form of annual credits applied to your account. Detailed information is available in the school offices and online.

Schnucks – obtain an eSCRIP card at Schnucks and register at www.escrip.com. Then, use your eSCRIP card every time you make a purchase – ECS will receive a credit of 1-3% of your purchase. eSCRIP cards are convenient and easy to use – they cost you nothing! You can get cards for other family members, grandparents, co-workers, etc.



Target – be sure your Red Card (credit card) is linked to make a donation to ECS (www.target.com). Target will donate 1% of all purchases to our school.
